# **Key Information**

### **Purpose**

Life Membership is offered by the WAPPA Board to a WAPPA member who has rendered long and valuable services to WAPPA. Life Membership recognises an individual who has made significant, high level contributions to WAPPA and WAPPA members as well as for education in Western Australia at state, national or international levels.

Constitution Part 9 (3) Life Membership states, membership is open to members who have:

- Rendered long and valuable service to the Association and education; and
- Been nominated for life membership in the manner prescribed by the Board from time to time;
- Been elected as a life member by the Board.

#### WAPPA Life Members will be entitled to

- **Membership for Life.** Exemption from the payment of the annual subscription fee. (Ordinary membership for active life members or Alumni membership for retired life members.)
- WAPPA Conference. Complimentary attendance to WAPPA Conference each year.
- Life Members Lunch. Complimentary invitation to attend the annual Life Members Lunch.

#### **Eligibility**

- WAPPA Life Membership is open to WAPPA members who have rendered long and valuable services to WAPPA and to education.
- A WAPPA Board Member, Life Member or Ordinary Member, may recommend a fellow WAPPA Member for life membership consideration.

#### **Guidelines**

- Recommendations are to be submitted using the WAPPA Life Membership Form, addressing the required criteria and;
  - May include other supporting documents and/or the names of other referees if applicable.
  - Must be received by the WAPPA General Manager at mhill@wappa.net.au
  - Must be reveived by 4pm Thursday 20 July 2023.
- The WAPPA Board will carefully consider recommendations and review evidence of the suitability of the member for WAPPA Life Membership.
- The WAPPA Board will not be compelled to appoint anyone who does not meet the criteria.
- The final decision to elect a life membership will rest with the WAPPA Board.
- The WAPPA Board will not be required to give feedback on their decisions.
- In accordance with the constitution, the WAPPA Board will review the life membership and selection criteria from time to time.
